Bethlehem Star Lodge #20 – 3rd Annual Gun Raffle Official Rules

- 1. By obtaining a ticket, you acknowledge that you have read, understand, and agree to abide by all rules governing the 3rd Annual Bethlehem Star Lodge #20 Gun Raffle.
- 2. A maximum of 1,200 general raffle tickets—numbered 0001 through 1200—will be issued. Each ticket costs \$25.
- 3. Tickets will be sold until the conclusion of the event or until all tickets are sold.
- 4. All tickets and payments must be returned to: Bethlehem Star Lodge #20, PO Box 1387, Bethlehem, PA 18016, or to any Executive Board member, prior to the raffle, for the ticket to be valid.
- 5. Unpaid tickets are not eligible to win.
- 6. All ticket sales are final and non-refundable, including cases in which a winner fails a background check. Ticket buyers are solely responsible for lost or misdirected tickets. Raffle ticket purchases are not tax-deductible.
- 7. By obtaining a ticket, you affirm that you are a law-abiding citizen, legally permitted to possess any firearm won, will use any firearm won safely and lawfully, and have obtained or will obtain proper instruction in firearm safety.
- 8. Ticket purchasers must be at least 18 years old and legal residents of the United States.
- 9. There is no limit to the number of tickets an individual may purchase.
- 10. A \$35 fee will be charged for any returned check.
- 11. All firearms offered as prizes are new, factory-made, standard over-the-counter models. No custom calibers or special-order designs are included.

Ticket holders must call ahead to confirm that their firearm is in stock before pickup.

13. All prizes are subject to availability. If a selected firearm is unavailable, an equivalent replacement will be provided.

- 14. Winning tickets will be verified by Bethlehem Star Lodge #20. Winners will receive a certificate prior to contacting Relic Hunter Firing Line. Only valid ticket holders with proper ID may claim prizes.
- 15. Winners' first initial and last name will be posted on the Lodge's website and Facebook page.
- 16. Winners will be notified using the contact information provided on the ticket stub within 10 days following the raffle. If the winner cannot be reached, it is the winner's responsibility to contact the Lodge at Bethlehemfopstarlodge20@gmail.com within 30 days. All prize certificates will be distributed after the entire raffle concludes.
- 17. Bethlehem Star Lodge #20 and Relic Hunter Firing Line make no warranty on firearms. Any issues must be addressed directly with the manufacturer.
- 18. Bethlehem Star Lodge #20 will never take possession of any firearm involved in this raffle. All transfers will occur through Relic Hunter Firing Line or another licensed FFL in accordance with federal, state, and local laws.
- 19. Firearms are non-transferable. The name on the winning ticket must be the individual who claims the firearm. Winners must be:
- 18+ to claim a rifle or shotgun
- 21+ to claim a handgun

All winners must successfully pass the required background check.

- 20. Winners may be required to demonstrate that the firearm is legal to possess in their state, city, or municipality before claiming it.
- 21. Winners are responsible for all associated costs, including but not limited to:
- Background check fees
- Transfer fees
- Taxes
- Shipping

If a firearm must be transferred to a winner's local FFL, all shipping and associated costs are the winner's responsibility and must be arranged through Relic Hunter Firing Line.

22. All municipal, county, state, and federal laws apply, including regulations enforced by the ATF. Bethlehem Star Lodge #20 operates this raffle under:

Northampton County Small Games of Chance License #25-00291 and Special Permit #11. All winner information will be handled in compliance with applicable laws.

- 23. The value of any unclaimed firearm becomes the property of Bethlehem Star Lodge #20.
- 24. This raffle is void where prohibited.
- 25. Bethlehem Star Lodge #20's liability is strictly limited to the purchase price of the ticket.
- 26. Neither Bethlehem Star Lodge #20, nor any participating person, business, or organization assumes liability for injuries, damages, or claims arising from or related to prizes.
- 27. Bethlehem Star Lodge #20 is not responsible for any injuries or accidents occurring during the event.
- 28. Bethlehem Star Lodge #20 will never sell or provide your contact information to third parties.
- 29. All decisions of the Gun Raffle Committee are final. If needed during the event, decisions will be made by a three-member subcommittee.
